	I will bring this animal to FOR ANIMALS INC adoption events as requested while in my foster care.			
	I will make reasonable efforts to find the animal a qualified adopter while in my foster care. I will notify FOR ANIMALS INC of potential adopters and comply with the FOR ANIMALS INC adoption process.			
	If not already spayed/neutered, I will take the animal immediately to a veterinarian to be spayed/neutered. In the case of a kitten/puppy, I will spay/neuter the animal when it reaches the required age of maturity and notify FOR ANIMALS INC in writing or by phone. The cost of spay/neuter will be covered when a FOR ANIMALS INC approved veterinarian is used.			
	If not already provided, I will take the animal to a veterinarian for necessary inoculations and examination. Foster animals will be taken to a FOR ANIMALS INC approved veterinarian and all expenses will be covered. If I adopt the animal, veterinary expenses become my sole responsibility.
